# **FIERCE FINANCIAL OBLIGATIONS**

2023-2024  
Season # 12

## DUE DATES

- Monthly fees are due on the 1st of every month.
- Payments made after the 11th are subject to a \$35 late fee. Each family is entitled to one (1) late fee waiver per season. They must communicate through email that they are requesting a waiver. This must be done by the 12th.
- You will receive a friendly reminder if you have not paid your monthly fee by the 12th.
- If payment is not received within 3 practices or arrangements are not made, the athlete will be removed from the team. All balances must be current in order for your athlete to participate in competitions.
- We will not allow an athlete to go into a second month without payment.
- It is simple, No Pay, No Play.
- If a modified payment plan is requested, we will attempt to accommodate your requests.

## CHILD CUSTODY/COURT ORDERS

**FIERCE** expects both parents/guardians to agree on all of the obligations before they commit to our program. Both parents/guardians must work together to ensure all standards are met. Financial agreements must be made beforehand between custodial parents and non-custodial parents. The parent/guardian signing this contract will be responsible for all financial agreements and standards.

## FEES and PAYMENTS

### USASF Membership

Every athlete is required to be a member of USASF. The annual membership fee is \$49\*\* and must be paid at [www.usasf.net](http://www.usasf.net). All athletes must be registered by September 1st. Each parent must register their athlete. \*\* Subject to change\*\*

### REGISTRATION/ COMMITMENT FEE

This is a non-refundable fee. This fee must be paid prior to an athletes first practice with their team. This fee is not pro-rated for athletes who join after the season has begun. This fee secures your roster spot.

### UNIFORM FEE

Uniform deposits are non-refundable. In the event you depart FIERCE once the uniforms have been ordered, you will not receive a refund and you will not receive the uniform. Uniforms cannot be returned to the manufacturer and we do not receive our money back on canceled uniforms. Uniforms are generally worn for 2-3 seasons.

## **FEES AND PAYMENTS** (continued)

### **MONTHLY TUITION**

Tuition costs will vary depending on what team the athlete is assigned to. Tuition is due from July to April ( 10 months).

Monthly tuition covers the cost of competition fees and coaching instruction. Monthly tuition represents the costs for the entire year. No refunds will be issued for monthly tuition. Payments do not depend on the number or length of practices. In the event a practice is cancelled, we will do our best to reschedule the missed practice.

## **TERMINATION OF CONTRACT**

- If an athlete quits after choreography occurs, **parents are assessed a \$400 inconvenience fee (quitters fee).**
- In the event that FIERCE has to ask an athlete/parent to leave our program, there are absolutely NO REFUNDS of any sort on payments paid to date.
- Failure to pay these fees will result in pursuing these fees civilly.
- In the event that an athlete can no longer compete due to unforeseen medical issues/concerns, it must be provided in writing by a physician that the athlete can no longer compete. There are no refunds granted on payments to date.

## END OF SEASON COMPETITIONS

Any team that receives a bid and will be attending, each athlete is required to pay the end of season comp fees ( these are not added into monthly tuition due to now knowing if a team will receive a bid) and coaching expenses.

End of the season fees only applies to athletes attending those events.

End of the season events require an additional coaching fee. These fees are per family. We do not charge these fees in advance.

## **PAYMENT POLICY/OPTIONS**

We utilize an online payment system called GOMOTION. This will allow you to check your cheer balance and make payments on your accounts. There is a convenience fee associated with utilizing this payment method. It allows for automatic payments. This is the preferred payment method.

Alternative payment options include paying cash or check at the gym.

All account balances need to be paid in full prior to the end of the season competitions. There are no exceptions to this rule.

## **ACCOUNT CREDITS**

In the event that your account has a credit balance on it at the end of the season, credits are non-refundable, non-transferrable. If you are returning to FIERCE, the credit will be applied to the next season. If you do not return to FIERCE, credits are forfeited and will go into the general FIERCE account.

## **FUNDRAISERS**

We offer various fundraisers throughout the season to assist with offsetting costs. If an individual is going to participate, it is important to follow all guidelines regarding collecting tax, deadlines and pick updates. Volunteers may be needed to assist with the fundraiser delivery/distribution.

Individual fundraisers are completely optional and non-refundable.

Each family is expected to participate in the Mandatory Fundraisers. Mandatory fundraisers are required to assist with purchasing new equipment, coach training and assisting with program operations. If a family opts to not participate in mandatory fundraisers, "BUY OUT" options are available. There are a minimum of 2 mandatory fundraisers per season.

## **PAYMENT EXPLANATION**

Monthly tuition covers coaching, tumbling and competition fees.

Please note that pricing is based on competition fees from the previous years and a set number of competitions per teams.

Due to the fact that we offer two payment plans, it is imperative that all fees are paid as outlined depending on payment plan selected.

### **Payment Options**

Each family must select a payment option by September 1,2023. Failure to do so will automatically result in Option #1.

## **COMPETITION SCHEDULES**

Competition schedules will be released upon final confirmation of pricing and dates from competition companies.



## **SIBLING DISCOUNTS**

Sibling discount is applied as follows:

1st child- No Discount

2nd child- \$10/ off tuition per month

3rd child- \$15 off tuition per month

Uniform and competition fees can not be discounted.

Sibling discounts will be discussed with parents individually.

## **PAY-IN-FULL DISCOUNTS**

If a parent/guardian wishes to pay for the entire situation by August 1st, they will receive a \$75 credit to be applied to the month of April.

## **CHANGE IN PRICING**

In the event that additional competitions are added to the schedule after the start of the season, this may result in an additional cost. Parents will be notified in advance if this should happen.

## **RETURNING ATHLETES**

Returning athletes will not have to pay for the Uniform package unless they need a new uniform. Returning athletes will be required to pay \$25/ per athlete for a new hair piece ( bow/ scrunchies, etc.).

Please feel free to ask if you have any questions or concerns regarding your account. Please feel free to contact us if any issues arise throughout the season pertaining to your account.

Each parent/guardian is required to read and sign the Financial agreement statement that is attached to the registration form.

Failure to do so will result in your athlete not being permitted to participate until the form is submitted.
